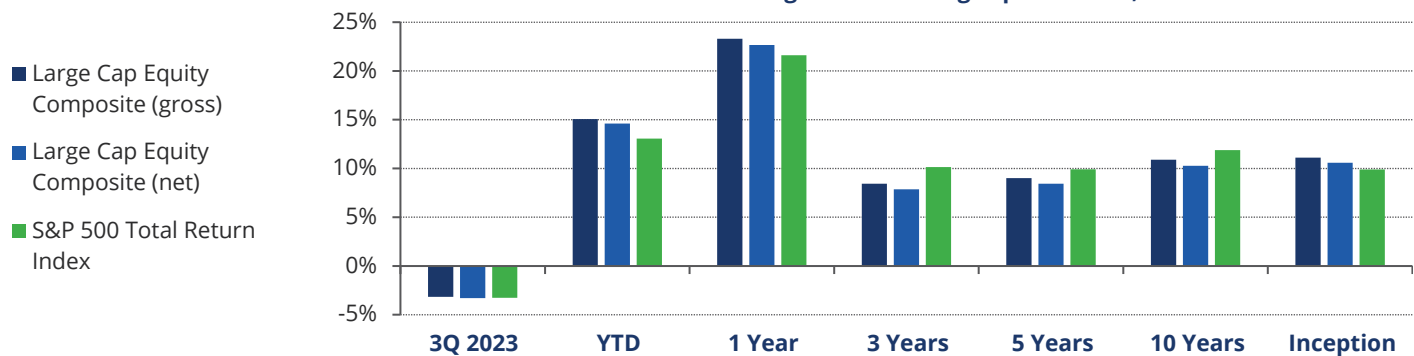
## Philosophy & Strategy

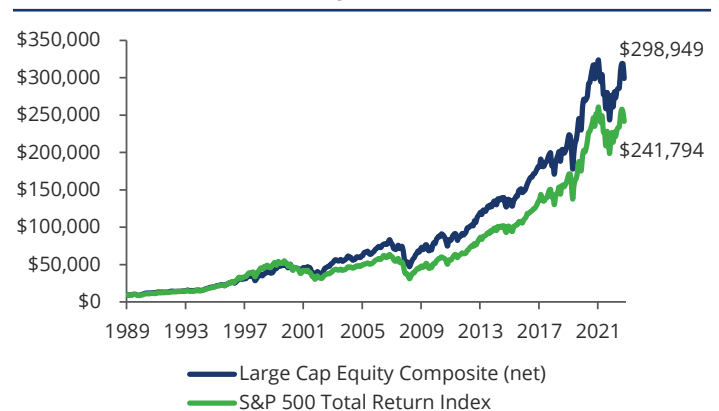

## Growth of \$10,000 Since Inception<sup>4</sup>

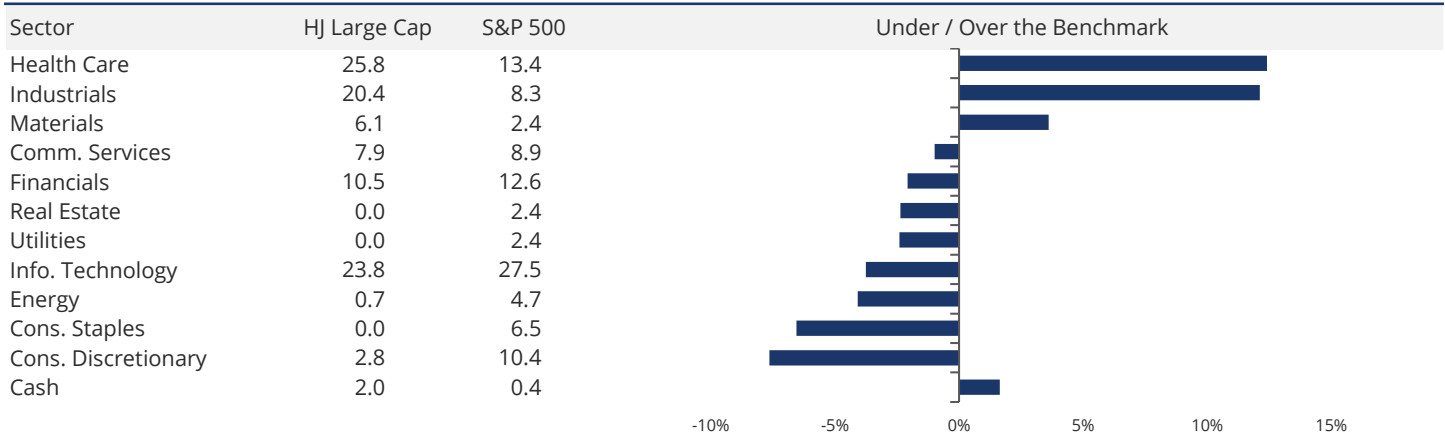
